First Aid Measures

Inhalation: Remove to fresh air.

Skin: Take off contaminated clothing, wristwatch, jewellery. Wash affected skin with plenty of water. Wash clothes and clean shoes before re-use.

Eyes: Immediately flush with plenty of water. If easy to do, remove contact lenses.

Ingestion: Immediately offer water to drink. Never give anything by mouth to an unconscious person. Do NOT induce vomiting unless directed by medical personnel. If symptoms occur, get medical attention.

Storage / Spillage

Storage: Minimum storage temperature: 0 °C. Maximum storage temperature: 45 °C
 Compatible materials for storage: stainless steel, fibreglass, plastic, glass lining. Keep out of reach of children.
 Keep away from food, drink and animal feed. Keep only in the original container. Partial crystallization may occur on prolonged storage below the minimum storage temperature. If frozen, place in warm room and shake frequently to put back into solution.
 Minimum shelf life: 2 years.

Spillage – SMALL QUANTITIES: Flush spill area with water. **LARGE QUANTITIES:** Absorb in earth, sand or absorbent material. Dig up heavily contaminated soil. Collect in containers for disposal. Flush residues with small quantities of water. Minimise use of water to prevent environmental contamination
