## **Environmental, Energy & Sustainability Policy**

To meet our responsibility to our customers, shareholders, employees, neighbours, and the natural environment Nurture Landscapes Group recognises its obligations to comply with the law and carry out its business in as environmentally sound manner as possible to protect the environment for future generations to enjoy.

We are committed to promoting and maintaining an environmental, energy and sustainability policy to ensure that the impact of our operations on the environment is reduced to as low a level as is practical and economically feasible whilst aiming to continually improve our environmental performance.

- Maintain and continually improve our environmental & energy management systems as part of the integrated management system, IMS and Energy Management System, EnMS compliant with the requirements of ISO 14001:2015 & ISO 50001:2018.
- Identify significant environmental aspects and manage their impacts. We do not communicate these aspects externally unless specifically requested.
- Establish environmental & energy objectives and targets and provide adequate resources to achieve these. Communicate these to all interested parties and review them at least annually.
- Ensure this Policy is made publicly available and communicated and understood by all our colleagues and other interested parties.
- Procure & use products & services that are sustainable and energy efficient e.g. FSC certificated, A+ labelled and design for energy performance improvement.
- Minimise damage when working on sites to protect flora, fauna, biodiversity and ecosystems.
- Become a carbon neutral business and make every effort to be net zero carbon by 2030.

This Policy will be reviewed at least annually and revised as necessary to reflect changes to the business activities, communications from interested parties and any changes to legislation. Any changes to the policy will be brought to the attention of all colleagues and other interested parties.
